## APPLICATION FOR MAF SUBSIDY APPROVAL

## **About MAF**

As a part of the Church of Jesus Christ, MAF believes in the doctrines of:

- \* the Divine inspiration and supreme authority of the Old and New Testament Scriptures
- \* God is Three in One, the Trinity made of Father, Son and Holy Spirit
- \* The two-fold nature of our Lord Jesus Christ, that He is both God and Man; His virgin birth, his death on behalf of mankind, His bodily resurrection; His present divine power and at the right time He will return in glory.
- \* The sinful fall of mankind, followed by moral sinfulness of all people, and our need for cleansing and renewal; being made right with God by faith through the death of Christ on our behalf; believers are set apart by the Holy Spirit; and will experience the resurrection of the body and eternal judgement by Christ.

The Council and Members of MAF affirm the following as our statement of faith and the message we proclaim.

- 1. We believe that the one living and true God has revealed Himself to be perfect in love and righteousness in all His ways, He is one Being, eternally existing in the three persons of the Father, Son and Holy Spirit.
- 2. We affirm that God who governs all things according to the purpose of His will:
  - \* reveals Himself to mankind through His creation,
  - \* has also revealed Himself through the action and work in history, for the establishment of His Kingdom, through Jesus Christ who is made known to us in the Scriptures.
- 3. We affirm that the Old and New Testament Scriptures are truly given by God
  - \* given by the inspiration of the Holy Spirit as the written Word of God
  - \* the only trustworthy authority for our belief and behaviour
  - \* to be interpreted according to their context and purpose, in obedience to the Lord who speaks through them in living power to us in our life situation today.

## **History**

In order to qualify for Church Rate fares the church or mission must have been affiliated with one of the following bodies:

- \* The Evangelical Alliance
- \* The Pentecostal Council of Churches
- \* The PNG Council of Churches

However, it is recognised that there are now churches and missions obediently serving the Lord Jesus and effectively spreading His Gospel who are not members of one of the above organisations. Therefore, any church or mission wishing to apply for church Subsidy

must be prepared to submit their Statement of Faith and Doctrinal Statement to the MAF-PNG Board.

MAF is an inter-denominational fellowship serving many different parts of the Church. All churches and missions receiving Church Rate must respect this inter-denominational role and acknowledge that the Holy Spirit is working in and through other churches and missions in PNG.

**Church Subsidy** is only applicable in the following situations:

- ⇒ Full-time Church or Mission workers.
  - Travel undertaken for trade stores or other commercial undertakings of a Church or Mission is <u>not</u> eligible for the Church Subsidy and must be charged at the appropriate general fare.
- ⇒ Full-time Church or Mission workers travelling on leave or to their home place.
- ⇒ PNG theological full-time students at approved establishments who are not receiving income from other means, for travelling to and from their home place during school vacations and practical ministry outreaches. Note: Student concessions do not apply.
- ⇒ Other part-time or volunteer workers or groups while on official Church or Mission work. These must be authorised to travel by the relevant Church or Mission authorities through an application.

## **Documentation**

- ⇒ In order to receive Subsidy for Church Flying the Church or Mission must fill out a subsidy request form and send it to the Mission Coordinator <u>at least 4 weeks before travelling.</u> MAF will then approve an appropriate Subsidy for each individual flight and inform the customer about the outcome of his application.
- ⇒ The customer must then book and pay for his travel with the appropriate MAF Base.

  Customers who received a Subsidy from MAF are expected to give us a written report about how the Subsidy has helped their Church for their ministry.
- ⇒ In order to receive Church Subsidy the passenger must have a valid K-card, an ID card stating that the Church or Mission employs the holder.
- ⇒ Each Church or Mission is responsible for ensuring that all travel at Church Subsidy Rate meets these requirements. Abuse of the subsidy may lead to its withdrawal.
